## General Policies:

Please initial all the following below, stating that you have read, understand, consent, and agree to the following policies to obtain our doggie daycare, grooming, and/or boarding services.

### Registration:

I represent that I am the legal owner or agent for the owner of the pet described in this application form. The Farm at Flint Creek (sometimes referred to in this document as “The Farm”) reserves the right to prohibit admittance to any pet for, including but not limited to, the following reasons: dogs must be at least 14 weeks of age before coming to our facility, pets must have proof of all required vaccinations, pets displaying any signs of an untreated or potentially contagious illness, pets that seem aggressive or have history of aggressive behavior towards people or other animals, AND all pets must have complete, up-to-date, and approved documentation on file including a complete registration form for each pet, medical and vaccine records for each pet, signed registration form and agreement for each pet. The Farm has the right to prohibit admittance to any pet we do not feel is a good fit for our facility. The Farm reserves the right to permanently remove my dog from its daycare or boarding facilities or grooming services at any time.

### Vaccinations Required:

Written confirmation of current vaccinations from your veterinarian are required for ALL animals obtaining services at The Farm with no exceptions. All pets must be current in accordance with our policy.

Dogs:

- ✓ Bordetella Vaccine Required
- ✓ DHLPP / Distemper / Parvo Virus Vaccine Required
- ✓ Rabies Vaccine Required
- ✓ Canine Influenza H3N2 or H3N2/H3N8 Bi-Valent Recommended
- ✓ Flea & Tick Prevention Recommended
- ✓ Puppies should have received all rounds of puppy shots, including rabies, and have been vaccinated against Bordetella.

**IMPORTANT!** With permission, any dog where we visually see a flea on them will be administered a Capstar pill upon arrival. We will separate your dog and call you first! Universal administration minimizes the risk that your pet will be exposed to fleas, both in the facility and transmission from other dogs and cats. If you wish for your pet NOT to receive a Capstar, please DO NOT sign in the box below. If you sign below, you are consenting to any and all risks that may be associated with Capstar, including but not limited to side effects, injury, or death.

There is a full-day boarding fee charged on day of arrival, regardless of check-in time and there is a full-day charge on the day of pick-up, regardless of pick up time.

## Contagion Exposure and/or Flea & Bug Exposure:

Animals, especially dogs, just like humans or children, are susceptible to transferring contagious illnesses between animals. Visiting areas where animals congregate can increase the risk for exposure to your pet. All our pets are required to show proof of vaccinations, which lowers the risk of any illness coming through our facility. Any pet that is not vaccinated is at a higher risk of acquiring an illness and will not be allowed at our facility. The Farm takes precautions to guard against such contagions, and especially monitors young and geriatric dogs, but we cannot make any guarantees or assurances that your dog will not be exposed. The same risks apply with fleas or ticks. We provide a Capstar pill to most pets that come to our facility and take other precautions to help prevent your pet from getting any bugs, but we cannot make any guarantees that your pet will not be exposed.

I understand that by taking my animal to any area where there are other animals, such as The Farm, my pet is at risk of contracting a contagious illness or coming in contact with fleas, ticks, or any other bug susceptible to animals.

I understand that while my dog is fully vaccinated, vaccines are not guaranteed and there is a risk that my dog may contract a contagious disease or illness. I agree that should this occur, I am responsible for my own pets' care and medical attention.

I agree to allow a 12-day waiting period after my dog has had its vaccinations to allow the vaccines to reach full protection potential and to ensure my dog has not has any negative reaction to the vaccines. Should I allow my dog to stay at The Farm less than 12 days after vaccination, I understand that my dog could be at risk of contracting a contagious virus/diabase.

If my dog comes to The Farm with fleas, The Farm reserves the right to deny my dog entry, at The Farm's sole discretion; and The Farm may provide my dog with a flea bath and I agree to be solely responsible for that cost.

## Deposits and Cancelations on Reservations:

We recommend reservations for all visits, drop-offs, and/or pick-ups. During any holiday season, early reservations are especially important. For boarders, the pet's first night's stay is due at time of drop-off. The rest of their stay will be paid for at time of pick-up. For daycare pups, daycare must be paid at time of drop-off or in advance. Money for your dog's grooming will be paid for at the time of pick-up.

If a cancellation for any of our services is necessary, out of respect for our facility, we need as much notice as possible to have room for other guests. For boarders, if you cancel less than 48 hours in advance, you will be charged 1 night of boarding. For grooming, if you cancel less than 24 hours in advance, you will be charged \$10.00. For daycare pups, The Farm reserves the right to charge a cancelation fee. Clients who cancel repeatedly or fail to appear for any scheduled appointments will be asked to pay in full in advance for future reservations.

## Fees:

The Farm At Flint Creek's overnight boarding fees are based on nightly standard rates with adherence to drop-off and pick-up time requirements. Alternative times can be arranged for an additional fee of \$10.00 per pet. Doggie daycare fees are based on standard daily rates and include one meal, snack, naps, and playtime. Grooming fees reflect the outstanding care your pet will receive during their stay and the extra work the staff here at The Farm has put in to our facility to make it a safe and comfortable environment for your pet. The Farm reserves the right change its fees at any time. All remaining payment is due at the time of pick-up and will include all boarding

charges in full as well as any additional activities, services, or snacks and any charges incurred due to any necessary medical treatment, treatment of flea or tick infestation, or other fees specified in this agreement.

I agree to pay for any and all outstanding charges prior to or at time pickup up my dog. I understand that should I not have provision for payment at the time of pickup of my dog, The Farm reserves the right to withhold my dog and continue to charge for continued services and any additional fees until payment is made in full. I understand that should I fail to complete payment within 7 days of the notified due date, The Farm may proceed with the pet abandonment procedure described below.

## Extended Stay or Suspected Abandonment:

The Farm understands that travel cannot always go as planned. In the event that you are not able to pick your pet up on the day you had scheduled, you will only be charged standard rate for the first night over your scheduled day. Any night after the first night, you will be charged the standard rate, plus an additional \$20.00 per day for your pet's accommodations. If a pet is not picked up by the arranged day, without notification, The Farm will attempt to contact the owner, emergency contact, and/or the pet's veterinarian. After three days with no notification, if abandonment is suspected, The Farm will attempt to place the pet into foster care. After one week with no notification, The Farm will attempt to re-home your pet. If The Farm fails to find a forever home for the pet, they have the right to surrender that pet to Almost Home Humane Society and will no longer hold responsibility for that pet. If you fail to pick up your dog for any reason, you release The Farm, its staff, owners, representatives, and agents from any liability and responsibility relating to your dog.

## Health Requirements:

I represent that my dog is in good health: is current on all required vaccinations: is free of fleas, ticks, and lice; and has not been ill with any known contagious virus or illness in the last 30 days or I have provided a certificate of health from their veterinarian that The Farm deems acceptable.

All pets will be taken aside and evaluated every day before entering areas with the other animals. Pets who are coughing or sneezing may not be admitted. If for any reason The Farm thinks that your dog could have an illness, they reserve the right to not allow your pet into the facility. Pets also must be free of external parasites and appear to be in good physical condition. All pets must be spayed or neutered unless they have made special arrangements with The Farm in advance.

## Medical Need:

In the event of a medical concern with your pet, we will attempt to contact you as quickly as possible. We will administer any aid we think is necessary. If we believe, in our sole judgement, that veterinarian care is advisable, we will first try to consult and/or schedule your pet with its own veterinarian listed on the registration form above. If contact cannot be established or if we think there is not enough time to get the dog to their own veterinarian, we will consult with an affiliated veterinarian clinic close in proximity to The Farm at Flint Creek or taken to Purdue University for special care. The Farm will make these and other decisions at that time.

I understand that in the event of a medical emergency, The Farm at Flint Creek has the authority to administer first aid treatment and procure the immediate assessment, treatment, and care of a licensed veterinary facility, including transportation, as The Farm deems necessary. I further agree that I shall be solely responsible for the cost of any medical treatment that my pet(s) receive because of any medical concern that exists or arises while in the care of The Farm.

When you leave your pet with The Farm at Flint Creek, you accept the responsibility for any expenses resulting from any outside treatment in the event of accidental injury, illness, or symptoms arising during or after the pet's stay with us, including transportation to and from such facility.

## Medications:

We can provide prescription medication to your pets during their stay. We will only do so if the medication is prescribed by a veterinarian and it must be specified on the medication form. We will need to know the amount and what time(s) of day your pet needs the medications. Prescription medication must be specified on the registration form at check-in or on the medication itself.

## Food, Toys & Bedding:

The Farm at Flint Creek will provide a high quality (canned or dry), low or grain free kibble for your pets at the cost of \$5.00 per day. We encourage you to bring your pet's food from home to ensure they are as comfortable as possible but it is not required. For any pet on a special diet or with special dietary restrictions or allergies should bring their own food. The Farm will also provide a raised bed in each kennel but we strongly encourage you to bring blankets/bedding, treats, and toys which will help your dog feel more at home. Any item from home must be safe and parasite clean. If we feel as if any item brought for your pet from home is unsafe or hazardous to your pet or others, The Farm has the right to withhold that item. The Farm at Flint Creek is not responsible for the safety of a pet because of a collar, toys, or bedding brought from home. The Farm is also not responsible for any damage done to your pet's belongings during their stay. As part of The

Farm's policy, every dog will be fitted for a walking halter as soon as they arrive. For your pet's safety, their collars will be removed and they will be hung outside of their rooms and not put on again until pick up. They will be fitted for walking halters for potty breaks and leash time and each dog will have "easy rip off" collars put on with their name on it, to help all employees identify each dog when they interact with them.

## Dangerous or Aggressive Animals - Refusal of Services

The Farm has the right to refuse any services at any time. In the event that your pet is too stressed or becomes dangerous to groom, The Farm has the right to refuse grooming services, stop grooming services, or cancel grooming services at any time before, during, or after grooming and client will be charged a grooming fee (for what was done up until that point). In the event that your pet becomes too stressed or becomes dangerous to The Farm's staff or the other dogs at The Farm, The Farm reserves the right to refuse boarding or doggie daycare appointments at any time before, during, or after the appointment has started and charge a fee for the dog's stay until you pick up the dog.

## Grooming Particulars

Although accidents are very rare, there is a risk when dealing with animals. Grooming equipment is sharp, and although we use extreme caution and care in all situations, possible problems could occur including, but not limited to, cuts, nicks, scratches, etc. and in most cases this can happen when an animal is wiggling or moving around. You understand and agree that The Farm shall not be liable for any grooming accident. Your pet's safety and comfort is very important to us. In the event an accident does occur, you will be notified of the accident. If the Farm feels it is serious, and the owner is not on-site, The Farm will seek immediate veterinary care for your pet with the closest available vet clinic.

Animals with severely matted coats require extra attention. Mats in an animal's coat grow tight, and can ultimately damage and tear the animal's skin, which can provide a breeding ground for parasitic infestations. The Farm will not cause serious or undue stress to your pet by de-matting. Mats can be very difficult to remove, and may require the pet to be shaved. Removing a heavily matted coat can cause nicks, cuts or abrasions due to skin growths trapped in the mats. Heavy matting can also trap moisture and urine near the pet's skin allowing mold, fungus or bacteria to grow, producing skin irritations that existed prior to the grooming process. After-effects of mat removal procedures can include itchiness, skin redness, self-inflicted irritations or abrasions and failure of the hair to regrow. In some cases, pets may also exhibit brief behavioral changes. If your pet needs to be shaved to remove matting, by signing below, you acknowledge that you agree to

this procedure, and any risk. There will be an additional charge for this process as it is time consuming, and causes extra wear and tear on grooming equipment.

Muzzling does not harm your pet and protects both the pet and the groomer. In some cases, muzzling may even calm a stressed animal, allowing the grooming process to continue. If your pet still acts in a way that is dangerous, the Farm has the right to stop grooming services at any time and a service fee will be collected. We do not muzzle unless your pet gives us a reason to. Other methods are used to calm your pet first; muzzling is a last resort. Dogs that require muzzling or extra staff to help manage them will be charged at a higher-than-standard grooming rate. This is because dogs showing aggression or acute nervousness take much longer to groom.

## Waiver, Release and Indemnification:

At The Farm at Flint Creek, our most important goal is the safety and comfort of your pet. We want your pet to feel 'at home' as much as possible, and we want to do this in the safest manner. However, injury, illness, or death may occur. Pet owners are solely responsible and liable for any and all actions of their pet during their stay at The Farm, this includes but is not limited to: injury to another pet, injury to a staff member, injury to a member of the public, damages of furniture, housing, or facility material destroyed by your pet.

Although all dogs are supervised, incidents and injuries may occur from playing with other dogs, which include, but are not limited to, bites, scrapes, scratches, sprains, and other self-harming injuries or death, and from our services provided to your dog, including, but not limited to, injuries from grooming and allergic reactions resulting in injury or death. I understand that there are inherent risks of illness or injury when dealing with animals—such risks include, but are not limited to, problems resulting from rough play, self-injury, and canine cough. I am aware that my dog will co-mingle with other dogs unless otherwise specified and that personnel are not present continuously after normal business hours. I understand The Farm will use reasonable precautions for the safekeeping of my pet, but The Farm and any of its owners, employees, and agents shall not be held responsible in any manner whatsoever for any injury, illness, or death of me or my dog, as it is throughout understood that I assume all risks. Fully understanding the risks, I hereby voluntarily assume all risks of my dog participating in services at The Farm.

AS THE REPRESENTATIVE OF ALL INTERESTED PARTIES PERTAINING TO THIS PET, I AGREE THAT IN THE EVENT OF INJURY, ILLNESS, DAMAGE, AND/DEATH TO ME OR MY PET RELATED IN ANY WAY TO SERVICES PROVIDED AT THE FARM, I HEREBY EXPRESSLY AND FOREVER WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS, DEFEND, AND COVENANT NOT TO SUE THE FARM AND ANY OF ITS FORMER, CURRENT, OR FUTURE OWNERS, DIRECTORS, OFFICERS, EMPLOYEES, CONTRACTORS, AND AGENTS FROM, AGAINST, OR FOR AND ALL INJURY, LIABILITY,

This agreement shall be governed according to the laws of the State of Indiana, and any litigation arising as a result of this agreement shall be brought in Tippecanoe County, Indiana. The descriptive headings used herein are for the convenience of reference only. As such, they are not intended to have any effect whatsoever in determining the rights or obligations of The Farm or the owner.
